## Affordable Health Coverage for Early Learners and Their Families

### HEALTHY KIDS MAKE A HAPPY CENTER.

Babies and young children grow, learn, and develop best when they receive quality health care. Early learning and child care providers and directors can play a vital role in connecting children, families, and staff to health coverage.

**ALL IN: HEALTH CARE FOR EARLY LEARNERS makes it easy for you to connect the children and families you serve to coverage.**

### What you need to know

- ▶ Open enrollment for affordable health coverage through Covered California is once a year, typically from November 1 to January 31.
- ▶ Eligible children, families, and individuals can enroll in no- or low-cost Medi-Cal year round.
- ▶ Medi-Cal and Covered California coverage needs to be renewed every year. Enrollment counselors can help.
- ▶ Special enrollment through Covered California is available anytime outside of open enrollment if you have experienced a qualifying life event, such as losing health coverage, loss or change of job, or having a baby.

### Lo que necesita saber

- ▶ La inscripción abierta para la cobertura de salud asequible a través de Covered California es una vez al año, normalmente del 1 de noviembre al 31 de enero.
- ▶ Niños, familias e individuos elegibles pueden inscribirse en Medi-Cal todo el año.
- ▶ Medi-Cal y Covered California deben renovarse cada año.
- ▶ Inscripción especial por Covered California está disponible fuera del período de inscripción si ocurre un evento en su vida que califique, como perder su cobertura médica, pérdida o cambio de empleo, o tener a un hijo.
